Dear Mr. President,

I am writing to you as a concerned American citizen and small business owner whose livelihood has been severely damaged by the unchecked power of Big Tech platforms. Your recent victory in the lawsuit against YouTube—where they agreed to pay \$24.5 million just yesterday for unlawfully suspending your account in 2021—highlights the very real harms these companies inflict on free speech and economic opportunity. This settlement is a powerful reminder that even the most prominent voices can be silenced, but it also underscores a broader crisis affecting everyday Americans like me, who lack the resources to fight back in court.

For years, I worked tirelessly to build a successful YouTube channel and Facebook page focused on conservative commentary and family vlogs, which provided the income my family depended on. That all changed when YouTube suspended my channel after I questioned CNN's reporting on the COVID-19 vaccine. Shortly afterward, Google abruptly withdrew funds from my business account, and Facebook demonetized and shadow-banned my page. Despite my account appearing to be in

good standing, they refuse to reinstate monetization. Overnight, I lost my livelihood, forcing me into financial hardship. I believe this was no accident but part of a deliberate pattern driven by left-leaning ideologies embedded in these tech giants' cultures, where conservative viewpoints are routinely suppressed to appease activist employees and advertisers.

Mr. President, my story is far from unique. Thousands of creators, entrepreneurs, and small publishers—many of them veterans, parents, and hardworking patriots—have seen their dreams crushed by similar actions on platforms like YouTube, Facebook, and Twitter (now X). These companies, wielding monopoly power, have colluded to enforce ideological conformity, costing American families their financial security and stifling the diverse voices that make our nation strong. Your own experiences, from the January 6 suspensions to this week's settlements (including Meta's \$25 million payout), prove that Big Tech's bias is not just a grievance—it's a threat to our democracy and economy.

I urge you to build on this momentum by directing your administration to:

- Launch a full antitrust investigation into Google, Meta, and other dominant players to break up their monopolies and restore fair competition.
- Advance legislation like the FAIR Act to hold platforms accountable for discriminatory deplatforming.
- Support tax incentives and grants for independent creators displaced by Big Tech censorship, helping us rebuild without fear of reprisal.

You have always fought for the forgotten men and women of America, and I know you understand this battle intimately. Please consider my plea as part of the chorus calling for justice. I would be honored to discuss my situation further or connect you with others in my community who have suffered the same fate.
